


PROVIDER ALERT ELIGIBILITY RE-DETERMINATION REPORTS JUNE 5, 2015

Using Intelligence Connect

"User Cheat Sheet" - June 2015

Concept

Intelligence Connect is software that runs inside a browser (I.E. 6+). It is a central location to run, schedule, export, and configure reports.

Log On and Get Reports

- 1. Log into Client Connect or Provider Connect
- 2. Click the Reports Link



3. For the Report List, click the **Document List** button (or link)



Intelligence Connect Gotchas!


- Avoid running reports with large date ranges to improve efficiency
- Reports are delivered via the Internet.
 Sometimes network traffic may slow delivery.
- Answer all your parameters, when presented, to avoid blank reports.

Scheduling and Parameters


- 1. Right Click a report name
- 2. Choose Schedule



- 3. Configure your report to suit your needs.
- 4. Click the **Schedule Button** when finished with configuration.



Configuration Notes



Parameters—Click the Edit button for each parameter and choose from the options.

Recurrence—set a pattern to distribute the report, or run it "now".

Format – Change the report Format. Popular settings include PDF, MS Excel, or CSV.

Destination—Save locally or send to multiple Email account, etc.
