Readjudication code	Formal description	Example of use
1	Allow Informational Modifier - Claim Reprocessed	Claim submitted with informational modifier denied incorrectly
2	Authorization Update - Claim Reprocessed	Claim previously denied for lack of auth is reprocessed due to authorization update
3	Authorization Waived	Claim reprocessed because special exception has been granted to waive Auth requirements
4	Benefit Plan Update - Claim Reprocessed	Claims reprocessed because covered/non-covered code requirements have been updated
5	Claim Billing Issue	Claims previously approved in error are reprocessed to deny due to billing issue
6	Claim Data Validated - Claim Reprocessed	Claim billing rules have been validated and claim is reprocessed
7	Claim Payment Calculation Corrected	Claims reprocessed due to missed fee schedule rate updates, application of UB Non-Covered charges, application of resource shared amounts, etc.
8	COB Correction - Claim Reprocessed	Claims reprocessed due to incorrect approvals or denials related to TPL
9	Duplicate Logic Review - Claim Reprocessed	Claims reprocessed due to incorrect approvals or denials related to duplicate claim submissions
10	Fee Schedule/Rate Update - Claim Reprocessed	Claims reprocessed due to initial notice of fee schedule updates

11	Funding Validated - Claim Reprocessed	Claims reprocessed due to initial approval under incorrect fund source
12	IMD Funding Rules - Funding Shift	Claims reprocessed due to initial approval under incorrect fund source – No new payments are issued to Providers
13	Incorrect Denial - Claim Reprocessed	Claims reprocessed due to incorrect denial and/or incorrect denial reason upon initial reprocessing
14	Place of Service Update - Claim Reprocessed	Claim reprocessed due to incorrect denial related to the Place of Service
15	Provider Record Updated - Claim Reprocessed	Claim reprocessed due to updates to the Billing Provider's data
16	PRP Audit Performed - Claim Reprocessed	Claim reprocessed due to an audit of PRP services
17	PT54 Funding Rules - Funding Shift	Claims reprocessed due to initial approval under incorrect fund source – No new payments are issued to Providers
18	Rendering Provider Update - Claim Reprocessed	Claim reprocessed due to updates to the Rendering Provider's data
19	Retro Eligibility / Eligibility Update Claim Reprocessed	Claims reprocessed due to retroactive updates to Participant Eligibility
20	Service Discontinued - Claim Reprocessed	Claims reprocessed due to the retroactive removal of a covered service
21	Timely Filing Waived	Claim reprocessed due to Timely Filing Waiver
33	UB Billing Issue - Claim Reprocessed	Claim reprocessed due to validation of UB claim billing requirements
48	UB Claim Review - No New Payment	Claim reprocessed as part of a UB claim review – No new payments are issued to Providers
49	Duplicate Claim - Orig Claim Paid by Previous ASO	Claim reprocessed to deny as the original claim was paid by the previous ASO

50	Pay Hold Provider - Claim Reprocessed	Claim reprocessed due to addition or removal of a Provider payment suspension
63	Auth Exception Granted - Claim Reprocessed	Claim reprocessed based on approval of authorization requirement exception
76	Claim Exception Granted - Claim Reprocessed	Claim reprocessed based on approval of claim requirement exception
77	COB Retro Update - Claim Reprocessed	Claim reprocessed due to retroactive addition/removal of TPL data to the Participants record
78	Combo of Service Rules Validated - Claim Reprocessed	Claims reprocessed due to violation of Combination of Service Rules
79	Authorization Waived - EP Period	Claims reprocessed due to authorization waiver during Estimated Payment Period
80	Retro Eligibility / New Eligibility Span Rcvd	Claims reprocessed due to addition of a new Eligibility span to the Participants record
81	Attending Provider Updated - Claim Reprocessed	Claim reprocessed due to updates to the Attending Provider's data
