## News and Reminders

- 1) A Notice of Recoupment of Retro-Eligibility and Overpayments has been mailed to providers via USPS and will be posted in the Incedo Provider Portal by December 29, 2021. To access your individualized letter/report within the Incedo Provider Portal:
  - Log-in to the Incedo Provider Portal and go to the "Downloads" screen
  - In the "Downloads" folder you will see all items that have not yet been downloaded (downloading means clicking on the file and opening/saving it)
  - There is a checkbox to display items already downloaded. This
    checkbox defaults to "unchecked" and will only show new items that
    have not been downloaded. Check the box to view all items; both new
    and those already downloaded.
- 2) The most current copy of the Eligibility Verification System (EVS) User Guide is posted to the Optum Maryland website, here.
- **3)** Optum Maryland office hours during the Christmas and New Year holiday are detailed in a provider alert, here.
- **4)** Providers are reminded to retrieve/use client-level COVID-19 vaccine status data from the IPP in your vaccination outreach efforts. For further information please view these <u>training materials</u> and <u>quick reference quide</u>.
- **5)** Providers are reminded to ensure that MCO ROI forms are signed and up-to-date and submitted to the Incedo Provider Portal.
